

Vimla Dubey D/o Late Ram Subhag Tiwari Resident of Satani Sarai, Bhriugu Ashram, Ballia (U.P.) here in after called and referred to as the "Setter Trustee" which term shall, to the context so requires and admits, means and include the settles trustee, his legal heir / heirs, executors and administrator, in view of necessary amendment which are required to be incorporated in the original instrument of the trust (Trust Deed) which was earlier on 26th October 2015 in preview of clause 10 of trust deed as per the following details.

- 1) That for deleting the name of Smt. Smita Dubey D/ O Mr. Umesh Chandra Mishra from Board of trustee due to her resignation from the post of secretary as per her resignation letter dated 10/03/2023 which is approved as per Resolution dated 12/03/2023.
- 2) That for change the portfolio of Mr. Vinod kumar Tiwari from Treasurer to secretary of trust as per Resolution of the Trust dated 19/03/2023.
- 3) That for adding the name of Mr. Vijay kumar Dubey S/O LATE Mahendra nath Dubey in Board of trustee, also appoint him Treasurer of the Trust as per Resolution of the trust dated 19/03/2023..

THIS DEED OF THE DECLARATION OF TRUST is made on the 26th day of Oct 2015 by Smt. Vimla Dubey D/o Late Ram Subhag Tiwari, Resident of Satani Sarai, Bhrigu Ashram – Ballia (Uttar Pradesh) Pin Code 277001, here in after called and referred to as the “Settler Trustee” which term shall to the extent the context so requires and admits, mean and include the settler Trustee, his legal heir/ heirs, executor /executors and administrator.

Whereas the settler trustee has a keen and earnest desire to serve mankind in general and the people of India in particular by creating a trust out of the money which he is seized and possessed of and which he has set apart for the purpose as detailed in the object clause.

Whereas the settler trustee has constituted a sum of Rupees 10000/- (ten thousand only) as initial corpus of the trust fund together with all the contributions. Additions, accumulations and investment in which the same may from time to time be invested, All other movable and immovable properties and assets the may from time to time vested in the Trustees or be received by them by way of donations or otherwise required by them or may come into their hands by virtue of these presents or by operation of law or otherwise howsoever in relation to the trust here by created.

And whereas with a view of to and for the purpose of constitute the Trust permanently as an irrevocable Trust for the purposes of carving on the objectives of the trust as mentioned hereafter under the object clause of this DEED OF TRUST, it is considered desirable the for purpose of creation of this public charitable Trust, the declaration of Trust should be made in the manner set out hereunder :-

NOW THIS DEED OF DECLARATION OF TRUST WITNESSE THE AS UNDER :-

1. Name Clause :-

That the name of the trust would be SANATAN SOCIAL WELFARE TRUST and abbreviation of which shall be SSWT.

2. Registered Office Clause :-

That the Registered office of the Trust would be situated in Ballia (U.P.) and the present address of the Trust Would be :-

Satani Sarai, Bhrigu Ashram, District – Ballia, - 277001 U.P. India.

3. Operation Clause :-

The area of operation shall be the whole of India.

4. Object Clause :

Following shall be the aims and objects of the Trust :

4.1 The Trust is being organized for the promotion of spiritual, physical mental, educational, development and upliftment of adults and children of all ages without any discrimination of caste creed or religion and in the interest of mankind in general.

- 4.2 To develop and establish a school, college or educational institution by takeover or collaborate with any institution or association for Professional, Technical, Physical, mental, spiritual and educational, Medical development, upliftment intelligence or its development.
- 4.3 To promote charitable values, Literature, science, art education and culture.
- 4.4 to undertake, organize, conduct and facilitate, courses, conference, lecture, research and education on various aspects and of science, technology, trust and other fields.
- 4.5 To aid or establish any institution technical or otherwise, to promote education of art Science or other related fields for the benefit of downtrodden and weaker sections of the trust.
- 4.6 To arrange / establish and maintain centers of adult education, vocational education technical training, low cost education, formal & non -formal education.
- 4.7 To promote and protect Indian Traditional music, dance handicraft handlooms, Art modern art & literature.
- 4.8 To run / operate different types of education program / school like formal, non-formal, pre-School for the education development of under privileged children of the community / trust.
- 4.9 To publish books, magazines, charts, issue related IEC (information, Education and Communication) materials and other periodical illustration for generating the income for the trust for the benefit of its aims.
- 4.10 To Open / run / manage institute / college of higher / professional / vocation education in any part of the country for providing quality education and training to youth and children.
- 4.11 To spread the ethos of freedom movement teachings & thoughts of great leaders, philosophers, thinkers, reformers and saints.
- 4.12 To promote National Integration, Communal Harmony, Universal Brotherhood and Global Peace.
- 4.13 To promote and advocate Human Rights and Fundamental Freedom for all without any discrimination of race, religion, caste color, sex and language.
- 4.14 To organize and take up health, Educational and welfare program for needy women and children on priority basis.

4.16 To fight against HIV /AIDS and other communicable diseases.



- 4.29 To issue appeals raise funds and accept gifts, donation subscription in cash or in kind and any property either movable or immovable for the achievement of the objective of the trust.
- 4.30 To acquire, purchase or otherwise own or under take on loan or lease or hire temporality or permanently and movable or immovable property necessary or convenient for the furtherance of the objects of the trust.
- 4.31 To undertake activities for 'sensitizing people to preserve the natural resources of our nation and to maintain the ecological balance of the area.
- 4.32 To provide and facilitate legal assistance to underprivileged and poor section of trust to fight for their rights and justice.
- 4.33 to help poor, widows, handicapped, orphans, old aged, mentally retired and under privileged section of the trust / community.
- 4.34 To work and fight against discrimination based on cast, creed, Colour, Gender, Religion, Faith, Race & Nationality.
- 4.35 To promote traditional games along with the contemporary sport among youth & others.
- 4.36 To work against the exploitation of Animals & Birds and make sincere efforts to protect them.
- 4.37 To celebrate annual day of the trust every year as cultural & social event.
- 4.38 To establish Citizen Forum (s) and Resident Welfare Association (s) for the development of high values of the Unity, Brotherhood, Communal harmony and peace.
- 4.39 To promote and support voluntary donation of Blood, Eyes and other parts of human body for the charitable purpose.
- 4.40 To save or protect National Heritage, Buildings or Places of the archeological & historic importance.
- 4.41 To spread the ethos of freedom movement teachings & thoughts of great leaders philosophers, thinkers, reformers and saints.

All the incomes earnings, movable / immovable properties of the trust shall be solely utilized and applied towards the promotion of its aims and objects only as set forth in the Memorandum of the trust and no profit, thereof shall be paid or transferred directly or indirectly by way of dividends, bonus, profits or in any other manner whatsoever to the present or past members of the trust or to any person claiming through any one or more of the present or the past members.



No member of the trust shall have any personal claim on any moveable or immovable properties of the trust or make any profits, whatsoever, by virtue of this membership.

AND GENERALLY to do in all public, charitable purposes for public benefit without any discrimination of Caste, Creed, Colour, Gender, Religion, Faith, race or any Nationality That in case any of the objects of the Trust are held to be non charitable within the meaning of section 2 (15) of the Indian Trust Act , or any statutory modification (s) thereof, the Trustee (s) shall not carry out such objectives.

5. FUNDS

5.1 The Trustees may accept donations, grants, subscriptions, aids or contributions from any person, Government, Local authorities or any other charitable institutions, in cash or in kind including immovable property without any encumbrance, but the Trustees shall not accept any receipt with any condition or terms inconsistent with the objects of the Trusts. While applying such receipts to the objects, the Trustees shall respect the directions, if any, by the granter, Any receipt with specific direction to treat the same as part of the corpus of the Trust or separate fund shall be funded accordingly.

5.2 The Trustee may raise all types of Loans (Term loan and working Capital Loan) with or without security from any Nationalized Bank / Financial Institutions for fulfill any above Mentioned Objects of the Trusts. All the Trustee will Jointly liable for repayment of Loan. The Board of Trustee (BOT) can mortgage the Movable or Immovable Property of the trust for raising any type of loan from any Nationalized Bank / Financial Institution for fulfills the objects of the Trust.

6. INVESTMENTS

6.1 All monies, which shall not immediately required for current needs shall be invested by the Trustees in eligible securities and investments, or in banks, Such investments shall be in the name of Trust or Trustees.

6.2 That the trustees shall invest the trust fund, carry on any business with the trust fund and /or enter into partnership on behalf of the trust, as they may deem fit.

6.3 That the trustees shall manage the trust fund and investments thereof as a prudent man would do the same. They shall recover all outstanding and meet all recurring and other expenses incurred in the upkeep or management thereof.

6.4 That the trustees shall receive and hold the income of the trust on behalf and for the benefit of the beneficiaries under the trust.

7. **BOARD OF TRUSTEES :**

The management and control of the Trust and Trust properties shall vest in the board to Trustees. The Board of trustees shall comprise not less than (3) and not more than (7) Trustees including the chairman and Secretary and Treasurer. The following shall be the founder member of the Board of Trustees.

The Board of Trustees shall consist of all the Three Founder Members. The terms of the Chairman, Secretary and Treasurer shall be for the whole life because they are founder members of the trust as well as the Managing trustee shall subject to the other provisions of rules hold the membership of the trust for life.

No act or proceeding of the Board of Trustees shall be invalidated by reason of any vacancies among its members or of any defect, which is not considered material by the Board to Trustee.

8. **Membership Clause**

The membership of the Trust shall consist of the following Main Points,-


Membership Clause :

The membership of the trust shall consist of the following categories :-

8.1 **Founder Member – Managing Trustee**

Founder Members Managing Trustees means all the said four trustees only continue to be Managing Trustees of this Trust for their life time and after their death the nearest and legal heirs will be authorized to do work as Founder Member Settler Trustees. They shall also be

empowered to nominate any person or persons as their successor or successors to work as Managing / Settler Trustee after their lifetime.

8.2 The said Three Managing Trustees shall have the power and duty to supervise the activities of the Trust and shall be the supreme Authority of the Trust.

Founder Member – Settler Trustees means all the Three promoters of whose names are subscribed in the Deed and include those who may replace them as provided under these rules.

8.3 **Other Member Trustee –**

The Managing trustee can appoint Maximum Four member Trustee for the smooth working of the trust. The membership period the member trustee should be maximum Five year. The Board of trustee of managing trustee can reappoint any of them if they deems fit.

9. **Termination of Membership :**

Membership of the founder members shall be terminated in the following circumstances :

9.1 On his death

9.2 Insanity

9.3 Physical disability which is the opinion of the Board of Trustees renders him incapable of being useful to the Society.

9.4 Resignation.

9.5 Indulging in activities which in the opinion of the board of Trustees are immoral or the interest or contrary to the objects of the Trust.

10. **Filling of Vacancies :**

In case the membership of the founder member comes to be terminated by any reason as mentioned in Rule -7 above the vacancy / vacancies so caused, shall be filled within six months of the vacancy having being caused by nominating another person, with his consent, by a majority vote of remaining Founder Members.

11. **Function and powers of the Board of Trustees :**

Subject to these rules the functions and powers of the Board of Trustees will be.

11.1 To promote the aims and objects of the Trust to do all such acts as are necessary and conducive to promote the interests of the Trust.

- 11.2 To acquire any immovable property through purchases, gift, exchange, hire or others i.e. for the trust to receive donations of gifts etc in cash or kind for and on behalf of the trust.
- 11.3 To administer and control the affairs and funds of the trust.
- 11.4 To sell, give on rent or otherwise dispose off any property of the trust for the benefit of any in the interest of the trust.
- 11.5 To discuss and review at the Annual General Meeting a report of the work done by the trust in the previous year together with the statement or accounts of the preceding year with the auditor's report of the accounts for the income and expenditure.
- 11.6 To prescribe salaries, honorarium, implements, wages, gratuities, overtime and travelling allowances etc, for the employees and office bearers of the trust to lay down service conditions and rules for them and to appoint such persons as employees of the trust as may be necessary.
- 11.7 To authorize any one or more of the office bearers to either jointly operate the account of the trust under their signature in the banks specified.
- 11.8 To suspend or terminate any office bearers, if five members of the Board of Trustees moves a no confidence motion and accepted by the Board of Trustees.
- 11.9 No members of the Board of Trustees shall be entitled to any remuneration for the work done for the Trust. They may however be entitled to traveling and daily allowance as approved by the Board of Trustees.
- 11.10 To appoint auditor(s) and legal adviser(s) for the trust.
- 11.11 Power to mortgage the Movable or Immovable Property of the trust for raising any type of loan from any Nationalized Bank / Financial Institution for fulfills the objects of the Trust.

12 Proceedings :

- 12.1 The Board of Trustees shall meet at least twice in year, The intervening period between the two meetings will not exceed eight months.
- 12.2 The notice accompanied by the agenda for the meeting of the Board of Trustees shall be issued by the Secretary with the approval of the Chairman so as to be dispatched to all the members at least 2 weeks before the date fixed for the meeting.
- 12.3 The Chairman may on his own or on the written requisition of at least three members of the Board of Trustees shall permit a special meeting to be convened.
- 12.4 The Chairman shall preside over all meetings of the Board of Trustees. In case of his absence for any reason any member of the Board of Trustees for this shall preside over with the consent of the members of board of Trustees.
- 12.5 The quorum of the meeting will be 2/3rd. There will be no quorum for an adjourned meeting.
- 12.6 All decisions in the meeting will be taken unanimously or in case of difference of opinion through majority vote, the chairman having a casting vote in case of tie.

12.7 In case expulsion of a member is under consideration the decision will be taken by the 2/3rd majority of the member present in the meeting.

13. **Powers and Duties of the Officer Bearers :**

13.1 **Power of the Chairman :**

- (a) The Chairman shall preside over the meetings of the Trust and other constituent units.
- (b) The Chairman duty shall be to ensure that these rules are enforce and resolutions of the the meetings are carried outs.
- (c) The Chairman shall call the meetings of the Trust and the other units through the secretary as per rules.
- (d) He shall exercise general supervision over affairs, of the trust and other organizations and may for this purpose issue instruction to those concerned.
- (e) In the Absence of the Chairman, Any Senior Member can preside the Meeting & perform routine operation.

13.2 **Powers and Duties of the Secretary ;**

- (a) The Secretary shall be executive officer of the Trust, and shall conduct all official correspondence under his signature and he shall have supervisory powers over all the instructions of the trust and shall have powers of visiting the instructions as and when necessary for discharging his duties.
- (b) He shall convene all meetings of the Trust on dues dates and give intimations thereof to members in time.
- (c) He shall prepare the agenda of a meeting under the directions of the chairman.
- (d) All contracts shall be entered into his name on behalf of the trust.
- (e) It shall be his duty to see that proper account is kept and documents prepared as per rules of all the incomes and expenditure.
- (f) He should get the accounts audited according to rules.

13.3 **Powers and Duties of The Treasurer :**

- (a) The Treasure shall be responsible for the issue of receipts; vouchers for funds received or paid out by the Trust. He shall be jointly responsible for the receipt and expenditure of the Trust.

(b) The Treasurer will in every meeting submit the report of the working of the Trust and its units along with a detailed statement of receipts and expenditure and cash and Bank balance for the consideration by the Trust.

14 **Account and Year :**

14.1 **Account and Audits :**

The Bank accounts shall be jointly operated by two the Secretary & Treasurer. The Trustee shall get maintained regular accounts of the Trust fund and shall get the same duly audited by a firm of Chartered Accountants at least once a year.

14.2 **Accounting Year :**

The accounts of the Trust would be closed and balanced on 31st March each year.

15. **Litigation :**

15.1 The trust shall sue and be sued in the name of the Trust.

15.2 All pleading including plaints, written statements, rejoinders, petitioner, affidavits, interrogations, compromise deeds, appeals, revision of review petition etc and in all proceedings in a court of law by or against the chair of the Deputy shall be signed verified.

and made by the secretary for and on behalf of the Trust in consultation with the chairman and all expense incidental there to shall be met out of the funds of the trust.

15.3 Before entering in to a compromise in a suit for other claims by or against the Trust the Chairman shall consult and obtain the sanction of the Board or Trustee.

In all other proceedings in government and semi government departments. Municipal in situations, statutory corporations etc, either under the Central Government or under any state government including executing the deeds of purpose, sale or otherwise acquisition or alienations of immovable property etc. and signing the income Tax returns, the Secretary shall act for and on behalf of the Trust in all matters and at all matters and at all stages in consultation with the chairman.

16. **Resignations :**

16.1 Any resignation shall be tendered to the Board of Trustee and shall take effect from the date of its acceptance by the board of Trustees.

16.2 The resignation of all other office bearers and members of the Board of Trustees shall be tendered to the Chairman who shall have the powers to accept the same subject to the approval in the Board of Trustees to take effect from the date of acceptance.

17. **Indemnity :**

Every office bearer and member of the Board of Trustees for the time being shall be indemnified against all expense for losses incurred lawfully in the discharge of his duties unless the loss so caused for the expenditure incurred is due to gross negligence, dishonestly or fraud etc, in which case the loss so caused or the excess expenditure so incurred shall be recovered from the person concerned.

18. **Miscellaneous :**

18.1 All funds, except such money as may be required meet the day to day expenses to a maximum of five thousand rupees, shall as soon as possible be deposited in the Trust's account in a Bank or Bank as may be approved by the Board of Trustees. The cash in hand shall be in the custody of the Secretary

18.2 All receipt and property of the Trust shall be derived and acquired by such means, which are not inconsistent with the objectives and ideals of the Trust. The receipts so derived and properties so acquired shall be applied towards the promotion and advancement of the objectives of the Trust as set out in the Memorandum of Association and the profit motive shall never override the fulfillment of the objects of which the society is formed.

18.3 Every member of the Board of Trustees and shall have the power at any time during the office hours and without prior intimation, to inspect all records and books of accounts etc, of the Trust and the office hours and without prior intimation, to inspect all records and books of accounts etc of the Trust and the office bearer concerned shall be liable to furnish all such information regarding the affairs of the trust as may be required by any members of the Board of Trustees.

18.4 Any change alternation or modification in the name or aims and objects of the Trust can be affected in accordance with laws of the land and by a resolution of the Board of Trustees adopted by $\frac{3}{4}$ majority of the members present and the number of member attending the meeting should not be less than $\frac{2}{3}^{\text{rd}}$ of the total numbers.

19. **Dissolution :**

19.1 If at any time it is felt that the Trust has not been able to work for the achievement of its objective or has or for any reason, constantly failed to achieve its objectives or that circumstances have arisen which render it impossible or inadvisable to continue to keep the trust in existence, the Trust may be dissolved in accordance with law.

19.2 Provided that the decision to dissolve the Trust it taken by the Board of Trustees either at its annual meeting or a special meeting convened for this purpose, through a resolution supported by not less than $\frac{3}{4}$ of the members present and



number of members attending the meeting should not be less than 2/3rd of the total members.

19.3 In case the resolution for the dissolution of the Trust has been duly adopted all the assets, in cash or kind including all the movable and immovable properties, furniture fixture etc, shall be disposed off in such a manner as the board of Trustees may decide.

Provided that all liabilities and debts on the Trust shall be discharged and as for possible and the remaining assets, if any, shall be handed over to such other organizations or institutions as are working for the same or similar objectives as the Trust or to other authorities as the Board of Trustees may decide.

Provided further that except for the arrears of salaries or emoluments or other accounts lawfully due to any office bearers or members of the Trust, no part of the assets of the Trust, in cash or kind, shall in no way be made over to any office bearer or other members of the Trust.
